Accordingly, following amendments in the Affiliation Bye Laws 2018 are hereby notified:-

Clause 2.3.5:- NO OBJECTION FROM THE RESPECTIVE STATE GOVERNMENT The Schools mentioned under clauses 2.1.5, 2.1.6, 2.1.7 and 2.1.8, seeking affiliation with the Board are henceforth, will be permitted to apply on SARAS Panel for affiliation under various categories with or without NOC (No Objection Certificate) from the forthcoming sessions w.e.f. the session 2026-27. In case, the school applies for affiliation without NOC, then the Board shall write to the concerned State Government to obtain their comments, if any, on the application of the school for affiliation with the Board. The department may furnish its comments regarding the said application, if any, at the link provided in the letter within 30 days of issue of the said letter. In case no comments are received within the said period of 30 days, a reminder letter will be sent to the concerned State Education Department to raise their objection, if any, within another 15 days, failing which, it shall be deemed that the State Government do not have any objection on the grant of affiliation to the school by the Board and the application of the school will be considered for grant of affiliation, if it otherwise, fulfils the conditions for grant of Affiliation as per the Affiliation Bye-Laws-2018 of the Board.




